In 2015, the Board had multiple meetings, mostly conference calls to discuss the election of two new board members: Richard Conlin and Laurel Nelson. On December 1, 2015, the full Board met to discuss activities for 2016.

BUDGET & FINANCIALS

As of December 31, 2015 the Washington EERI Chapter had \$3,043.46 in the account held by EERI in Oakland. The significant expenses for 2015 were related to the EERI Distinguished Lecture held at the University of Washington and for the expenses related to having a booth at the Canadian Conference in Earthquake Engineering.

Twenty five EERI members elected to pay Chapter dues for a total of \$825. The chapter dues are set at \$25 per year.

CHAPTER ACTIVITIES

EERI Distinguished Lecture by Dr. David Wald

On January 21, 2015, the Washington State EERI Regional Chapter and the University of Washington hosted Dr. David Wald to give his distinguished lecture titled: Challenges in Estimating Real-Time Earthquake Shaking & Impact.

The event was co-hosted by multiple departments at the University of Washington including: Civil and Environmental Engineering, Earth & Space Sciences, Urban Design and Planning and Human Centered Design & Engineering.

Approximately 100 people attended the event. After the main talk, a group of USGS scientists and the WA EERI Board invited Dr. Wald for dinner.

11th Canadian Conference on Earthquake Engineering

The 11CCEE took place from July 21-24, 2015 at the Victoria Conference Centre in Victoria, BC. The BC EERI and WA EERI Chapter had a booth for the duration of the conference to highlight the need for cross border collaboration on seismic issues. Mark Pierepiekarz and David Gonzalez from the WA EERI Board attended the conference and manned the booth on behalf of WA EERI.

ELECTION & ELECTION RESULTS

The Board elected two new Directors in 2015: Mr. Richard Conlin and Ms. Laurel Nelson.

Mr. Conlin is a well-known advocate for seismic safety. He was a City of Seattle Councilmember from 1998 to 2013. He is currently a consultant and affiliate faculty at Evans School of Public Affairs at the University of Washington and Antioch University where he teaches "Resilience and Emergency Management", "Environmental Policy" and "Leadership in the Public Service".

Ms. Nelson is the Deputy Director of City of Seattle Emergency Management. She provides a wealth of experience in the field of emergency management having been involved with City of Seattle, City of Bellevue, City of Kirkland and King County.

The goal in bringing these two new outstanding Directors is to bring more diversity to the current Board.

President David Gonzalez has stated he intends to step down as President at the next elections to be held in October 2016. He intends to remain in the Board as Past President.
